### Area Of Study:

This course introduces students to legal norms and its characteristics and how they are implemented. By discussing comparative legal systems, the adoption of the Romanistic Legal system in Egypt, and the application of the civil law system and its legal and constitutional consequences. It also deals with rights and responsibilities which guide the relationship between individuals and groups on one hand and the political system on the other. It touches on judicial institutions and their role in the settlement of disputes. Adding to that the general rules relating to cases viewed by courts, the rights and responsibilities of the litigants, and the definition of the accused and his/her rights as embodied in domestic laws as well as in the international instruments of human rights, all of which in an interactive atmosphere that allows students to share their opinions, and use their team work skills. The course prepares students for higher legal courses in different departments.

### **Description:**

This course introduces students to legal norms and its characteristics and how they are implemented.
